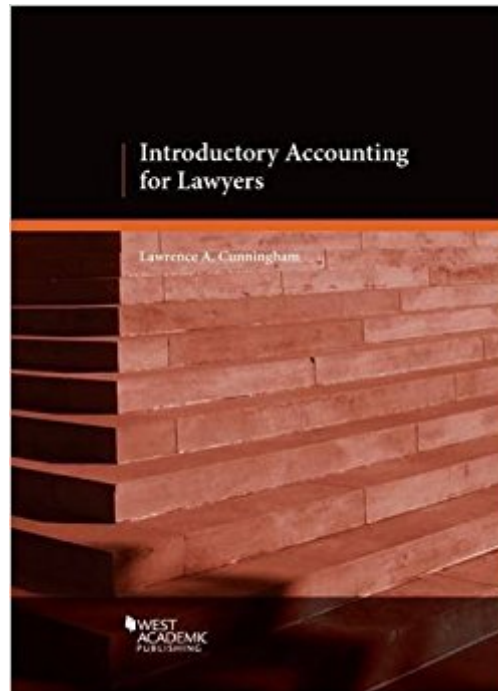

This textbook is exceptionally awful.
